By utilizing the Services, Customer agrees to be bound to all rules and regulations applicable to Customer's deposit account at The Gifford State Bank as established and amended by The Gifford State Bank which are specifically made applicable to this Agreement. - 2. Fees for Services shall be payable in accordance with a schedule of charges as established, and amended, by The Gifford State Bank from time to time. Charges shall be automatically deducted from Customer's account and The Gifford State Bank shall provide to Customer notice such debit(s) monthly.
- 3. Collected funds must be available for distribution from Customer's account as of the close of the business day on the scheduled payment date. Payments will be mailed on the business day following the scheduled payment date. Approximately five business days should be allowed for payments to be received and posted by the payee.

- Errors in amounts, payee codes or payment dates entered by Customer.
- Errors in addresses, account numbers or other information provided to The Gifford State Bank by the Customer.
- Late fees or other similar charges imposed by payees and incurred by Customer.
- Consequential or incidental damages for negligent performance by The Gifford State Bank of its services.
- Damages arising from unauthorized access to Telephone or Internet Banking software.

Regarding passwords: Once the Internet Banking Agreement and Enrollment Form has been completed and a login user ID and password for access to The Gifford State Bank's internet banking site has been selected, Customer is solely responsible for the use of The Gifford State Bank's internet banking site by anyone who utilizes its correct

password. The Gifford State Bank will have no duty to further verify the identity of any Gifford State Bank Internet banking user with a valid password. The Gifford State Bank will act on instructions received under the authorized password.
